Bondex Matt contains the unique Long Effect technology, which means that the active, protective agents are encapsulated and only released, when necessary - e.g. during rainy or damp weather. Traditional wood protection products will release the majority of the active agents in the first period after application. This means that your wood will be extremely well protected for the first period of time, but then the level of active agents remaining will be too low to keep up the good protection. The Long Effect technology ensures that the active agents will be released over a longer period of time and thereby the protection of the wood is extended significantly. |
